### VI. PRESENTATIONS -

A) Questa Geology & Hydrogeology - Paul Bauer & Peggy Johnson, NM Bureau of Geology at NM Tech Principal Geologist Mr. Paul Bauer and Principal Hydro-Geologist Peggy Johnson displayed a power point to the Governing Body regarding their study regarding the water issues in Questa. Mr. Bauer stated that he was approached in 2011 by Mr. Ron Gardiner to assist the Village with things like aquifer mapping and evaluations of aquifers as well as models of groundwater systems. He stated that they have been doing these types of studies in Taos County for about 18 years. He stated that they have been working on finalizing the geological map of the Questa area in creating two geologic cross sections through the areas of Village of Questa municipal water wells, 1 and 2. Mr. Bauer summarized the findings of the study and also stated that a final copy of the study has been given to Ms. Trujillo for the Village of Questa records. The information can also be viewed on their website.

At this time a motion to take a 5 minute break was made at 7:07pm by Councilor Ortega seconded by Councilor Jaramillo.

Mayor Gallegos called the meeting back to order at 7:13pm.

B) Petroglyphs on the Rio Grande – Mr. Elmer Salazar

Mr. Elmer Salazar, along with Mr. Malaquias Rael Chair of the Questa Economic Fund Board reported informed the Governing Body about the following:

- They are moving forward on April 1<sup>st</sup> with the formation of the Community Advisory Group.
- They have met with the Questa School Board and several businesses in Questa to understand what the community's perspective is on Economic Development.
- Reviewed reports and projects that have been planned in the past.
- We have to know where water is being utilized and where it coming from collecting a lot of water history. We will be able to deliver a document that serves as direction for the Village of Questa.
- There are housing challenges.
- Taos Mountain Energy Bars plan to move into business park-with help of \$438,000 in LEDA funding that
  will be invested in the business park building. Creates a food hub concept capability. All equipment and
  improvements belong to the Village.
- Talking to Taos Mesa Brewery regarding them opening up in Questa
- Need to get roads at Business Park built as well as solar array.
  - C) Summer Events Series Ms. Claire Cote and Ms. Lynn Gitter

Ms. Claire Cote informed the Governing Body about the Luz es Vida Questa Event Series and summer projects to the Governing Body. The events will run from March to October.

Ms. Cote also presented a budget summary with a total budget of 26,573.00.

The following is a breakdown:

- In kind/other funding 15,919.00
- NFGNHA 2015(pending) 3,000.00
- Chevron Questa (proposed) 3,708.00
- Questa Econ. Fund Board 3,946.00

Mayor Gallegos stated that he is in full support of the events and supports Ms. Cote in presenting to the Questa Economic Fund Board. Councilor Jaramillo, Councilor Ortega and Councilor Romero thanked Ms. Cote for her presentation.

D) Christmas Fair – Ms. Gayle Martinez

Ms. Gayle Martinez, proposed a Winter Event Series in Questa. The concept for the series is to showcase a Northern New Mexico Christmas. The series would run from December  $1^{st} - 31^{st}$ . Events such as farolito displays, tours, tree lighting, window decorating contests for homes and business, food demonstrations, caroling events, tying church services, promote businesses. Also, purchase booths for arts & craft fairs and could be used for different events.

Mayor Gallegos thanked Ms. Martinez for her presentation. He stated he was in support of this going before the fund board. Councilor Jaramillo asked if they would be working under the umbrella of a non-profit. Ms. Martinez stated that that is an option although she would prefer working under the Village. Councilor Ortega stated he certainly supports her efforts in pursuing funds from the fund board. Councilor Romero thanked Ms. Martinez and stated that it is a great idea and it will show that there is unity here in Questa.

# E) Water Lines/Tailings – Ms. Peggy Cross

Ms. Peggy Cross stated that she is still concerned about the water lines that are still laid in mine tailings. She stated that local realtors are telling people who want to buy property in Questa that we are toxic. She stated that she has been damaged permanently health wise. She suggested that the superfund should have taken care of this issue. She stated that there is a huge amount of cancer in this area. She heard it's too late to get the EPA to do anything about this. We need to get these lines replaced. She stated that she had an expert, Mr. Lawrence Bailon, who was going to come in to present with her but he was unable to attend. She stated that she is willing to assist in identifying the lines that are in tailings. She would like the Council to call her and give her things to do to assist in this effort at 586-1396.

F) Public Hearing – Questa Water & Sewer Ordinance No. 2015-141

Mayor Gallegos opened the Public Hearing at 8:40pm and asked if there were any people present who would like to comment or express any concerns.

- Mr. John Hollander, owner of Questa Lodge and RV Park stated that he runs a seasonal business busy
  three months out of the year. He was concerned that with this proposed ordinance his water rates would
  double and triple. He feels like RV Parks are been unduly penalized and are being classified incorrectly.
  He requested that the council reconsider moving RV parks to another classification.
- Mr. Bobby Ortega, owner of Sierra Vista RV Park stated that along with water the sewer also goes up. A mobile home park would have more usage because of the fact that they are full time residents with larger square footage. The other issue is the sewer classification, he asked the Council to consider basing the sewer on the return flow. He stated that it seems we are investing money into our business and we he asks that the Council re-consider the classification.
- Mr. Malaquias Rael inquired about the amount the rates were going up. Mayor Gallegos stated that there
  would not be a rate increase. Other proposed changes were citizens able to make payments on connection
  fees and giving the Administrator some flexibility to work with customers on their bills and some
  classification changes.

Councilor Ortega stated he would like to see how the Town of Red River has their ordinance set up regarding the water and sewer.

Mayor Gallegos stated that they will take these suggestions into consideration before adopting the Ordinance.

There being no other public comments Mayor Gallegos closed the Public Hearing at 9:50pm.

# VII. <u>ACTION</u> ITEMS -

<u>DISCUSSION</u> – A) Questa Volunteer Fire Department – Chief Max Ortega & Deputy Chief Mark Ortega

Mayor Gallegos informed Chief Ortega that the Governing Body asked for their presence at the meeting this evening so that the Governing Body could be updated on the Fire Department. He stated that one of the questions the Governing Body had was regarding the purchasing of items such as bunker gear and other items purchased by different grants that the Governing Body had not been made aware of. Mayor Gallegos stated that it is important that the Governing Body know these things so that when they are asked by citizens they know how to answer.

Chief Ortega went over the grants that he has received since he has been Chief. He stated that they have been lucky in getting some FEMA grants from the State Fire Marshal's Office. Deputy Chief Ortega stated that they need to replace their bunker gear every 10 years.

Councilor Romero inquired how many volunteers the department currently has. Deputy Chief Ortega stated that he believes there are 25 currently on the roster.

Councilor Ortega stated that all grants should come through the Administrator's office so that she is aware of them. Chief Ortega stated that they do not have an issue with doing that.

Ms. Shannon stated that they met with the Fire Marshal's Office to clear up any misunderstandings regarding paying utilities and other items out of the Fire Fund. Also, all items that the Fire Department purchases need to be on the Village inventory if the money to purchase them came through the Village. They need to be part of our asset inventory listing.

Mayor Gallegos stated that the reason they want to be updated on these things is because we want to have a unified voice when it comes to answering the questions that arise.

Councilor Romero also asked why they don't request a new building so that their vehicles aren't left outside. Deputy Chief Ortega stated that we have applied for a grant for a new fire house in the past and were denied. Mayor suggested we talk to Commissioner Fambro regarding this.

A discussion was held regarding the possibility of bringing back the Fiestas.

D) Discussion, Consideration & Action – Approval of Grant Writer Contract with Mr. Amalio Madueño

Ms. Trujillo stated that we did go out for RFP and we received just one proposal. She stated that Mr. Madueño has reviewed the contract and has requested a couple of minor changes: Page 1 (A) under Scope of Work. He would like it to read 'Seek federal, state or other grants....' instead of 'Secure federal, state or other grants....' Also, add an item 10 that would read, 'allow for grant writer to seek other grant opportunities that develop during the contract period.'

Councilor Ortega asked if this would overlap with our lobbyist contract. Councilor Jaramillo stated that this grant writer is for the purpose of Economic Development. A discussion was held regarding the amount of the contract. Mayor Gallegos stated that these are some of the things that Mr. Elmer Salazar put together. Councilor Jaramillo stated he was fine to pass this contract tonight. He stated that the scope of work fits because they all can be economic development. Village Attorney, Vanessa Chavez suggested that the Council approve it in this form and re-structure the scope of work which would give the Mayor the authority for final approval, since Mr. Madueno has already started working. Councilor Ortega stated that he would like to table this item and see the contract restructured before we approve it.

A motion to table the contract until the April 7, 2015 meeting was made by Councilor Ortega, seconded by Councilor Romero.

Other discussions were held.

A motion to approve the contract was made by Councilor Jaramillo. There was not a second.

Mayor Gallegos brought it back to discussion.

Councilor Jaramillo stated that his issue is that every meeting it seems that we are tabling things and not getting things done. Councilor Ortega stated that he is not going to approve something that he is not comfortable with. He stated that this scope of work contradicts with the scope of work of our Lobbyist.

Councilor Ortega asked for clarification on the Page 3, Item 6(C), last part of paragraph. Ms. Chavez stated that she can put in a statement saying 'the seller also understands that the Village is under no obligation to provide any funds until approval has been made....'
