VI. PUBLIC COMMENTS - (It is the policy of the Governing Body to accept public comment. • Ms. Margaret LeJuste – Ms. LeJuste, President of the Friends of the Questa Public Library requested the Governing Body consider adding the following to this fiscal year's upcoming budget:

1) Per capita contributions.

2) ADA compliance upgrade and seasonal maintenance for the parking area and library entrance.3) Increase hours for Librarian and her assistant.

Ms. Roberta Sanchez-Campbell, Village Resident – Concerned about the speeding on Cabresto Road.

- Requested that Village consider posting better signs or speed humps to slow the traffic down. She is concerned that someone is going to get hurt.
 Mr. Jim Vaughn, Village Resident Mr. Vaughn inquired about the status of the Animal Control Ordinance. A discussion was held regarding taking animals to Stray Hearts and for Taos County to pick
- up vicious animals. Ms. Janice Vaughn stated that the Village needs to get some kind of agreement regarding the vicious dogs and we need to cite the owners of the loose dogs. Mr. Vaughn stated that he would like to be part of a group to get this going. Councilor Ortega would like to see what the Village Council would like to see in this ordinance. It was decided that Councilor Cisneros would spearhead the
 - Work Study Session which would be held on June 9, 2015 at 6:00pm.

Public Comments were closed at 6:30pm.

VII. PRESENTATIONS -

Mr. Charlie Deans with NM Main Street who is on contract with the NM Economic Development Department brought the Council up to date on the Frontier Communities Initiative Project and the Metropolitan Redevelopment areas. He stated that he wanted to make sure the Council was comfortable with the pathway the project was headed.

A) Mr. Charlie Deans -Frontier Community Project and MRA (Metropolitan Redevelopment Area) Update

The 'Façade Squad' is looking at two tentative buildings in Questa to improve. The proposed buildings are Rael's Market and the building next to the OCHO gallery. Questa is the recipient of a \$5,000.00 grant from the NM Resiliency Alliance to assist with façade improvements and we are hopeful the Questa Economic Development Fund Board will match this amount.

Councilor Ortega asked who the facade quad is. Mr. Deans stated it is made up of volunteers who come out and make the improvements. It is a community event.

Mayor Gallegos stated that this is a great opportunity for Questa. The Council agreed for Mr. Deans to move forward.

VIII. PUBLIC HEARING -

Re: Economic Development Project Taos Mountain Energy

Mayor Gallegos opened the Public Hearing at 7:08pm and asked if there were any people present who would like to comment or express any concerns.

Ms. Chavez stated that this current ordinance will amend the existing ordinance to allow the Village to move forward with the plan to move forward with Taos Mountain Energy Bars. She stated that this ordinance along with the Project Participation Agreement and the Intergovernmental Agreement will be up for consideration and approval at the May 17th Council Meeting.

Councilor Ortega inquired who the recipient of the funds from the NM Economic Development Department would be. Ms. Chavez stated that Taos Mountain Energy would be the recipient of the funds and the Village of Questa would act as the fiscal agent for the funds. Councilor Ortega asked if the Town of Taos is fine with that. Ms. Trujillo stated that the current MOU with the Town of Taos does not include this particular project so if we need a fiscal agent we would have to amend the MOU, which the Town of Taos is aware that there may be an amendment at some point.

Mr. Daniel Gallegos, local business owner stated that since the equipment is going to be purchased for their use and they decide to pick up and leave, does the equipment go with them? Ms. Chavez stated that if all obligations are met the equipment does go with them. He is concerned that businesses are coming in and using Questa to expand by receiving all this funding and equipment and then just pack up and leave.

Mayor Gallegos stated that he understood that the equipment belongs to the Village. A discussion was held. Ms. Chavez stated that she will get more information on this. Councilor Ortega stated that as long as everything is in writing.

There being no other public comments Mayor Gallegos closed the Public Hearing at 7:23 pm and stated that this public hearing will continue at the May 17th council meeting.

XII MATTERS FROM ADMINISTRATOR

Ms. Trujillo informed the Governing Body on the following:

- Ms. Susan Godina will be here on Wednesday to inspect the work done on Cisneros Road and to audit the
 file so that this project can be closed. We are waiting on HO Construction to provide us with the as built
 drawings.
- The streetlights will be working again very soon, the bulbs have been ordered.
- Mr. Romero is taking the lead on filling out the water rights application to get the transfer through. Additional information was need form Mr. Romero.
- Attended ICIP and Budget training and it was very informative.
- Asked for guidance regarding the graffiti at Molycorp Field. Mayor Gallegos suggested that the public see
 the pictures of the damage so that they are aware as to what is happening. We need the help form the
 public. Councilor Romero suggested getting involved with Crimestoppers. Councilor Ortega asked if the
 police are patrolling the parks. Councilor Ortega suggested having a police officer live at Molycorp Field
 for security purposes. A discussion was held.
- Mr. Michael Steinberg of DFA will be here for a week beginning May 18 to assist her and Ms. Shannon with some finance questions that they have and to get a good beginning balance for the next fiscal year.

Councilor Ortega inquired about when the preliminary budget is due. Ms. Trujillo stated that it is due June 1st. A public hearing will be held on May 19th or sooner, if possible. Councilor Ortega stated that he prefers a work study session rather than discussing it at a Council Meeting. Councilor Ortega would like to ask all the questions he needs to ask so that he feels comfortable with it. A discussion was held. It was decided that a budget work study session be held on Thursday, May 14th.

XIII. MATTERS FROM MAYOR AND COUNCIL

Councilor Ortega inquired about the procurement for the DOT project and the Sewer project. Ms. Martinez stated that she will get Councilor Ortega the information from Joe Moore regarding the DOT project. Regarding the sewer project Ms. Trujillo stated she will begin working on that. Also, he directed Ms. Trujillo to ask Chief Bates when they patrol the area. Councilor Romero stated that the Volunteer Fire Department, the Public Works and the Security from Entact and Tetra-Tech could drive down during the daytime hours and the Police Department could patrol at night.

Councilor Jaramillo inquired about when Caselle will be online. Ms. Trujillo stated that we are ready to get going, we are just waiting on Caselle. She stated that she has requested a copy of the agreement since this was done before she began working here. Councilor Jaramillo also inquired about if we have heard back from the State Engineers Office regarding the water rights. Ms. Trujillo stated that she has requested something from them in writing because she does not agree with their findings.

Councilor Cisneros inquired if the Village e-mail was working because he has not received anything in a month. Ms. Trujillo stated that she will follow up with Ambitions tomorrow regarding this.
