- Opening a community kitchen so that residents can produce their items and sell them.
- Adding onto Questa Business Park for Economic Development

Mayor Gallegos proposed that we use the CDBG monies for Wastewater Improvements. Councilor Cisneros stated that at one of the last meetings the Council had decided to do an assessment of the sewer to identify the needs in different areas. Councilor Ortega stated that at the March 3, 2015 Council meeting the Council decided to approve the \$50,000.00 state appropriation money for the engineering of wastewater line extension. Councilor Cisneros asked if a location needs to be decided on right now and what locations are we looking at. Mayor Gallegos stated that we are looking at the Cabresto Road area.

Councilor Ortega stated that the application is due on March 18. Councilor Ortega also stated that he prepared some cost estimates for sewer line extensions on Cabresto Road, Abra Road and Embargo Road. Councilor Jaramillo agreed with this project stating that the Village is at a point where we can start concentrating on sewer projects.

V. <u>PUBLIC COMMENTS</u> - (It is the policy of the Governing Body to accept public comment. Because your particular issue is not on the agenda the Governing Body cannot respond immediately, but may direct staff to address issues at a future Council Meeting. Public comments are limited to a maximum of three minutes.)

Ms. Pam Kidd – Ms. Kidd stated that she has passed out some paperwork to the Council. Ms. Kidd informed the Council that on Sunday, February 1, 2015she came upon a 2 car accident. She stated that she was the second person to call 911 and remained on the scene for an hour. She stated that the injured person was bleeding profusely form the nose and mouth and she did have him in her vehicle because of the weather. She stated that it took 28 minutes for a response. She stated that her purpose is to continue to bring this issue up and to encourage the Council to look into how the response time could be cut. She stated that she has spoken to Mark Gallegos to have the Taos County handle the EMS and Fire services. She stated that we could have three more full-time employees and someone would always be at the station and we would have 24 hour coverage. She is asking that the Council get back to her for the next meeting to discuss this. She stated that she has researched this extensively.

Ms. Trujillo – Village Administrator Loretta Trujillo recognized the following employees:

- Ms. Dina Coleman Hired as the Village Receptionist, began working on March 2nd.
- Mr. Jamie Archuleta Received his Water I certification
- Public Works Department Recognized the department for their work during the winter weather and working long hours.

Village of Questa Regular Council Meeting March 03, 2015 • Police Department – Thanked the department for their hard work great attitudes.

<u>Chief Bates</u> - Informed the Governing Body that Officer Garcia completed the NM Police academy's certification by waiver program and graduated first in his class.

<u>Taos County Sheriff Jerry Hogrefe</u> - Sheriff Hogrefe introduced himself as the newly elected County Sheriff and also recognized his predecessor Councilor Romero stating that he has some big shoes to fill. Sheriff Hogrefe stated that he would like to attend community meetings throughout the county at least three or four times per year to update about what is going on with the Taos County Sheriff's Office. Sheriff Hogreff updated on the following:

- Working closely with Crime-stoppers they hold 7,000-7,500 active warrants from all agencies in the County.
- Held a series of community meetings in Taos where 7 law enforcement agencies were participating for community input.
- Reaching out to all homeowner associations / neighborhood watch
- Crested a Taos County Facebook page
- Working with all schools
- Vision is to solve cases and prevent crime
- DWI Checkpoints
- In Partnership with BLM and Forest Service- Received grant money for overtime
- Concerns regarding the Penasco Health Clinic closing on April 1st put more pressure on the Taos County EMS. Looking to train deputies in first aid to assist.
- Tri-County possible closure Extra burden on departments and EMS
- More video arraignments are being done reduce costs in transfer
- Hired two additional deputies

Mayor Gallegos thanked Sheriff Hogrefe for his update and for attending the meeting this evening. Mayor Gallegos also stated that he would like to maintain a good working relationship with the Taos County Sheriff's Office.

VII. <u>PRESENTATIONS</u> – Swear-In of Village of Questa Police Officers
 A) Officer Victor Alvarado & Officer Brian Garcia

Village of Questa Regular Council Meeting March 03, 2015

Ms. Trujillo informed the Governing Body that Officer Victor Alvarado completed the academy in December and Officer Brian Garcia completed the academy in February. Ms. Trujillo stated that all our officers are all certified.

Questa Municipal Judge Michael Rael administered the Oath of Office to Officer Garcia and Officer Alvarado.

VI. PUBLIC HEARINGS -

A) 2015 Community Development Block Grant (CDBG)

Mayor Gallegos opened the Public Hearing at 6:39pm and stated that this is the second Public Hearing that has been held.

Ms. Trujillo read aloud the purpose and information regarding the Community Development Block Grant to the people of the public who were present. The Public Hearing was then opened to the public for their input and suggestions.

Ms. Holly Howard, citizen, inquired about the last public hearing and what ideas were presented. Ms. Trujillo stated that the ideas presented were:

- Contacting the owners of vacant buildings in town to see if they are willing to sell or rent their properties in order to open business there.
- Opening a community kitchen so that residents can produce their items and sell them.

Councilor Ortega stated that in the past we have used these funds for basic infrastructure needs. The last project was a water project.

Ms. Howard inquired if adding or completing the Business Park would be suitable for the CDBG. Councilor Jaramillo stated that this would fit the funding criteria.

There was no other public input at this time.

Mayor Gallegos closed the Public Hearing at 6:46pm.

B) Village of Questa Water & Sewer Ordinance

Mayor Gallegos opened the Public Hearing at 6:47pm.

Ms. Trujillo stated that one more Public Hearing will be held regarding this proposed ordinance as well as it going up for approval at the March 17, 2015 Regular Council Meeting.

Ms. Holly Howard asked if the tailing pipes could be relayed along Old Red River Road going south. She asked if the water pipes on going up in the area of Vigil Road have been taken out of the tailings that they were laying in and have been put in better soil so that the tailing would be seeping into the water. Mr. Vasquez stated that there are no tailings going up to Vigil Road.

Ms. Trujillo informed the Governing Body that the following items were looked into as requested in the last public hearing:

• Structure of the water service rates – Ms. Herrera polled several Municipalities close to our size to see how their rates were structured. All six municipalities were all different.

There was no uniform way that it was done. Ms. Trujillo suggested we keep the way we are doing it for now, knowing that this is a working document that can be amended if needed.

• Utility Bill due date - Ms. Trujillo stated that currently it is due 20 days after the day of mailing. She suggested we change it to 15 days after the day of mailing. This would allow us to clear these balances before another billing cycle is started.

Mayor Gallegos closed the Public Hearing at 6:53pm.

VIII. ACTION ITEMS -

A) Discussion, Consideration & Action – Approval of Resolution 2015-10 Re: Grant Agreement with NMED / Special Appropriations

Ms. Trujillo stated that this Resolution is for \$100,000.00 for Water Rights Purchase and is necessary for purpose of the Village requiring a fiscal agent.

Ms. Trujillo stated that this Resolution is for \$40,000.00 for Well and Storage and is necessary again for purpose of the Village requiring a fiscal agent.

Ms. Trujillo asked for clarification on how we will be using this money. A discussion was held. Councilor Ortega suggested that should look at replacing the water well pumps. Mr. Vasquez stated that the pumps need to be replaced and need to be drilled deeper. It was decided that we see how much we can do with the \$40,000.00 regarding the pumps and drilling.

Ms. Trujillo stated that she also needs clarification on Resolution 2015-09 that was passed last Regular Meeting regarding the \$50,000.00 for Wastewater System Improvements. It was decided by all the Council to use the money for the planning and design work for sewer line extension on Cabresto Road.

IX. FINANCE DEPARTMENT - Ms. Karen Shannon

A) Approval of Unpaid Vouchers

Ms. Shannon stated that the vouchers and bank balances presented to them are as of Friday, February 27th.

Councilor Ortega: Voucher for Safety Instruction Ltd., LLC, for \$7,000.00 – Ms. Shannon stated that this is a grant from Chevron to the Fire Department for a Res-Q-Jack stabilization kit. Councilor Ortega stated that he does not have a problem with it as long as it is run through the Administrator's Office. Ms. Trujillo stated that this item was not. Mayor Gallegos stated that the Governing Body should know about these grants so that we know what is going on. Councilor Romero stated that the Council made a request last meeting that the Fire Department be present to address questions from the Council. Ms. Trujillo stated that they were not able to be in attendance this meeting. Ms. Trujillo stated that they will be placed on the next agenda. Mayor Gallegos stated that they need to come before the Governing Body and answer questions and concerns that the Council may have.

Councilor Ortega asked Ms. Shannon when the BAR's will be coming before the Council for approval. Ms. Shannon stated that they will be up for approval next council meeting. Councilor Ortega also asked for monthly financial reports. Ms. Shannon stated that they will have them on a regular basis as soon as everything is caught up.

- Street Lights When will they be working? Ms. Trujillo stated that the ones to the North side should be on as we speak. She stated that there are others out in town that we are responsible for.
- Cisneros Road Project Ms. Trujillo stated that the contractor is waiting for Joe Moore to come do the inspection. She will continue to pursue this.
- Application for DOT Project Request Ms. Trujillo and Ms. Martinez stated that they are working on the request.

Mayor Gallegos stated that a discussion or decision needs to happen regarding the Kit Carson lease agreement. He feels that we should at least get half of the rent they will be receiving from Taos Energy Bars. The Mayor would also like Mr. Reyes to come before the Governing Body to do a presentation regarding the Business park building.

Mr. Jim Vaughn inquired about the Animal Control Ordinance. A discussion was held if the Village of Questa would move forward on its own or wait for the County. It was decided that in one of the past meetings that the Village would move forward without the County. Ms. Trujillo stated that she will call the Village Attorney and move forward on this.
