A. Approval of Bid for Village of Questa RFP# 2017-01

Mr. David Henry of Henry Architects, stated that five sealed bids were received. Of the five bids, he considered one to be unresponsive for the reason that they did now acknowledge the addendum. The apparent low bidder was Sunrise Builders, who are based in El Prado, with a bid of \$48,250.00. Mr. Henry stated that he is familiar with the company, their work, and their staff. They are a licensed contractor. There were no additive alternates during the bidding process; that is not to say that we cannot get someone under contract.

- 50 He recommended Sunrise Builders be awarded the contract, carefully look at the project budget and if there is enough money to support an additional scope we can execute a change order.
 - The grant money needs to be used by June 30, 2017. We have a very short window.

Councilor Lawrence Ortega asked if there were any local contractors (Questa) that showed interest in the project. Mr. Henry stated no. Mayor Gallegos stated that the local contractors he spoke to were not interested at this time. Mr. Henry stated they tried to reach out to all of the contractors they could.

Councilor John Ortega asked Mr. Henry if we were over budget, since Option A was priced at \$40,000.00 and the low bid came in at \$48,250.00. Mr. Henry stated that our overall project budget is \$90,000.00. The \$40,000.00 was his best pricing as to what he thought the project might cost. He does not believe we are paying too much for the scope that went out for bid. Councilor John Ortega stated that we had \$12,000.00 budgeted for the interior paint and we had thought the staff could paint and use the money for something else; was the painting part of the bid? Mr. Henry stated the painting was not part of the bid documents. Additive or deductive change orders can always be done.
