#### VII. PRESENTATIONS

A) Presbyterian Medical Services - Mr. Larry Martinez, Presbyterian Medical Services Director

Mr. Larry Martinez, Region Director for the North Central Region for Presbyterian Medical Services stated that Questa has a big place in his heart. His father was born and raised in Questa and lived here until he was 18. Mr. Martinez stated that he is responsible for oversight of the Questa Health Center.

Mr. Martinez went over all of the services that are provided at the Questa Health Center. The Questa Health Center is a Federally Qualified Health Center which means they turn away no one and also provide a sliding scale for those with no health insurance. He stated that the behavioral health services are growing. He introduced Ms. Patty Torres who is the administrator of the Questa Health Center now for close to 8 years.

Mr. Martinez stated that he will be back to report on situations that affect the Questa Health Center; he stated that they are here to stay and have been putting money into the facility for improvements. He thanked the Village of Questa for their support of the Questa Health Center.

Councilman Jaramillo thanked Mr. Martinez and PMS for the role the clinic plays in the community. It means a lot to the people so they don't have to travel to Taos or further for health care.

Councilman Ortega echoed Councilman Jaramillo's sentiments. He stated that PMS is doing great work with behavioral health and the opioid crisis.

Ms. Evelyn Coggins stated that we had a great dentist and have two great nurse practitioners; is there a doctor in our future that will be brought in. Mr. Martinez stated that they have been trying to recruit a doctor now for about 5 years; there are not a sufficient amount of doctors available but are trying to attract them by forgiving their student loan debt.

Councilman Gonzales thanked Mr. Martinez for being here and it is exciting to hear about all of the services that are provided. He would like to see PMS concentrate on the opioid epidemic. He stated that the Council is more than glad to help them with anything they need.

#### B) Presentation of National Library Week Proclamation

Mayor Pro-Tem Louise Gallegos thanked all of the library volunteers, board members and librarians for being present at the meeting tonight. Mayor Pro-Tem Gallegos read the Proclamation aloud.

Library Director Sharon Nicholson stood up to say a few words. Ms. Nicholson stated that on behalf of all the library workers present tonight, they would like to express their sincere thanks. She stated that in addition to this being National Library Week, it is also Library Workers Day. Ms. Nicholson also recognized former Librarian, Ms. Carolyn Anderson. Ms. Nicholson informed the Council that they remain committed to this

Libraries are more than books; we are community centers, information centers and learning centers and our library workers are extra special. Our Advisory Board Members are the people who assist in getting the programs together; they let me complain, they encourage me. Members of the Friends of the Library are present; we would not have a library without them. Ms. Nicholson also thanked the Village for honoring them.

Councilman Jaramillo stated that he believes that Mr. Maestas should inform everyone on the Capital Outlay monies. Mr. Maestas stated that the Village has received \$580,000.00 for the expansion of the library this year from the Legislature. We are all very excited about this.

Councilman Gonzales stated that he was working with Senator Cisneros a few years back and the brother of the Governor of Pojoaque asked if they knew if anyone was a need of a building. Councilman Gonzales stated that we were in need of a building to house a library. The Governor stated we could have the building if the Village pays to get it up to Questa. We got it to Questa and everyone pitched in to put it together and this became the Questa Public Library. He thanked the library workers and the volunteers.

Councilman Ortega stated that our library is very important in our community. It is the backbone of getting our kids involved in the community. Thank you for all the programs that have been implemented. He thanked them for doing such an amazing job.

Councilman Jaramillo thanked Ms. Nicholson and all of the volunteers, Board Members and Advisory Board. He thanked Ms. Carolyn Anderson for all her hard work in getting the library going, along with her husband Andy.

Mayor Pro-Tem Gallegos stated that she cannot say thank enough; the library is very near and dear to her heart. She was part of the advisory council and then a board member. Whatever they need, I will be there.

## X. MATTERS FROM ADMINISTRATOR, MAYOR AND COUNCIL

Mayor Gallegos informed the Council that he was at the school board meeting regarding the property for the Village well. They asked for an evaluation of the cost of the property before they donate the lot. The school board is concerned about the Village being able to keep the gate locked and secure because there was a third party who thought they had rights to go through that gate; a survey was done showing they have no access. Mayor Gallegos stated that they asked him to make the request to the Council to put an adequate gate.

Councilman Jaramillo suggested we consider placing a section of asphalt where the gate sits. It may help with melting the snow quicker.

Mayor Gallegos stated that the school board just wants to make sure the property is secure. He asked the Council for their consent to submit a commitment letter to the school board stating that we will address that western gate. As we are constructing the building and the fence, we will see how much it will cost us for additional security.

It was the consensus of the Council to move forward with the letter of commitment.

Mayor Gallegos stated that graduation is the same weekend as memorial weekend. The police department would like to bring in extra help. Chief Lamendola will come before the governing body with the request.

Mayor Pro-Tem Gallegos stated that the Little League president approached her with some concerns regarding the field. He stated that there is a gate that needs some repair. Also, a while back, a request was made to Chief Lamendola that we get a memorial for Officer Shores and he has been dragging his feet on it. She stated that she did tell him that the individual that made the request was in very poor health and wanted to know that he was not forgotten because he saved the life for our Mayor who was in office at that time. He stated that is was a matter of funding, and she told him that she could help with the funding, to just let her know. She stated that she has not heard from him and would like to be on record to say she is very upset and disappointed with Chief Lamendola.

Councilman Ortega asked if we could do a Proclamation in Officer Shores memory until a memorial is placed at the police department. Mayor Pro-Tem Gallegos stated that she is not very coherent at this point. Councilman Ortega also stated for the record that he was not happy with the article in the April edition of the Questa newspaper. He received calls about it and believes it was done in very poor taste. He does understand that we have no oversight of the paper but the article regarding the 'local toilet cleaners' should not have been in there. He thinks at the very least, an apology is owed to the Questa citizens. Mayor Gallegos stated that Councilman Ortega speaks on behalf of the entire Governing Body in regards to this. This is not how we want our community represented. He stated that he will be meeting with Ms. Mapes very soon to discuss this with her. Councilman Jaramillo suggested an apology to the citizens be published in the May edition of the paper. Councilwoman Gallegos stated that yes, people understood it was a joke, but we have been trying to get away from that label for many years now and for her to bring it up again by calling us just 'toilet cleaners' is disappointing. Councilman Ortega stated that this is how a lot of people make a living and it is not what their proper job title is. Councilwoman Gallegos stated that these people take pride in their work. Councilman Gonzales also state that he was also very disappointed and hurt; having someone come from somewhere else and label us this way is uncalled for. He believes she should move on and look for work elsewhere. Councilman Ortega stated that the whole purpose of that paper was to promote economic development in this community; be a part of the rebranding efforts. This does not help; it hurts us.

Councilman Ortega stated that he received a complaint about a yard and asked if we have an ordinance in place that would address this. Mayor Gallegos stated that we aggressively pursued a property a few years ago and it cost the Village a lot of money. He stated that we will look into the Ordinance and see how we can be pro-active about working with the property owner to get it cleaned up. Councilman Ortega stated that getting the roll offs here for cleanup day is also important. A discussion regarding the dumpsters was held. Mayor Gallegos asked Mr. Dan Darnell of Waste Management if bins are available for a cleanup day. Mr. Darnell stated that there are. Councilman Ortega stated that in the interest of economic development maybe the QEDF can assist with the tipping fees associated with the cost. 

Councilman Ortega asked Ms. Martinez if she is still posting agendas at the post office and supermarket. He has a couple of constituents call him about it. Ms. Martinez stated that she is still posting at those places as well as on the Village website. It was suggested to post agendas in several of the local businesses as well. Ms. Martinez stated that she will post at several different locations.

Councilman Jaramillo stated that there is a dumpster off South 522 that has trash by the dumpster that has been there for over a week that contains construction materials.
