Ms. Jeannie Masters - Requested that the street light in front of her home be fixed. Ms. Masters stated that she was here last year to make the same request and nothing has been done. Mr. Maestas stated that he has addressed this issue and it has been fixed twice. He again has the electrician looking into it.

Judge Michael Rael -1) Informed the Governing Body about the bill that the Supreme Court is proposing that would dissolve all Municipal Courts. He stated that all 81 Municipal Judges are opposed to it. Judge Rael has spoken to our Representative and Senator regarding this and they have stated they will not be in support of it. He is asking that the Governing Body also not be in support of this bill. All citations would then go to the Magistrate Courts and no money would be given to the municipalities. 2) Judge Rael stated that there have been very little no citations given since we got our new officers. There are people speeding during the day and people who are passing on the no passing zones. He asked if the village could have a full time officer to patrol during the day.

79 80 Ms. Lindsey Mapes reported on the following for the QEDF for 2018:

81 82 The Visitors Center was open 7 days a week from mid-June to mid-October, five hours per day. They were able to cut their costs by 75%.

The welding lab project is still in the works; hoping for an August start date.

They are working with the Questa Creative Council on the gateway signage project and the light pole banner project.

Ten grants were written last year.

They have been very active in the Questa to Red River Trail meetings. Five events were implemented and are looking to add two to five more this year.

The Questa Lodging Project received a grant from the LOR Foundation to pay for a feasibility study; draft I has been completed and the final draft will be complete on February 1st.

91 92 The Questa del Rio Colorado newspaper is celebrating their 1 year birthday party. Everyone is invited on February 14th at Rael's Store at 5:30pm.

B) Questa Fire Department – Chief Mark Ortega

A) Questa Police Department – Chief Nicolas Lamendola

Chief Mark Ortega reported on the following:

There were 128 Fire calls – 400 EMS calls. He stated that these numbers are about average of what they've run before. Wasn't able to get the report from the state that breaks down the calls.

- Fire department roof repair 4 quotes were received. They range from \$6,000.00 to \$62,000.00. The two lower bids were to repair the existing structure; the second two were to remove the metal and replace it. He would like to get it replaced but knows they do not have the budget.
 - Structure and Turn-Out Gear Have a shelf life of 10 years. They budget for 2 sets of gear every year/\$4,000.00 per set. They have about 16-20 volunteers.
 - Wildland gear it is outdated; we don't have a set we can use. He is looking into grants to purchase the gear. The cost is \$1,500.00 per set.
 - Upcoming Trainings NM Fire Fighter Association want us to host the hazmat class again in March. Entry level wildland firefighter training in April. Firefighter I Class will be held this summer. Firefighter II class is a 2 week class held in Socorro.
 - Currently recruiting new members. He is working on getting fliers to put up and a notice in the paper.
 - Councilman Gonzales asked how much money we get from the fire marshal's office. Chief Ortega stated that they got \$84,279.00 for the main station and sub-station. We also have the loan payment of \$37,000.00 for two trucks.
 - Councilwoman Gallegos suggested they apply for the Chevron grant annually. It is still available.
 - Councilman Ortega stated that most of the wild land firefighting is on private land. Chevron property is the biggest private land area we have to protect. Since it is private land, Forest service or BLM will not come out and assist. It would be worth applying for the Chevron grant for this reason.
 - A public information officer class will be held at the county on March 5, 6, and 7th.
 - Garage doors at EMS the engine caught the corner of the garage and pulled it down. Two estimates were given. The insurance estimate was lower than the two we have received. The insurance company is reviewing the other 2 quotes to see if we can receive more money from them. Mayor stated we have to put a scope of work together. We may have to find the money to pay for the remaining \$6,000.00. It is currently temporarily secured. Councilman Gonzales asked if the drivers are sent out for drug tests after accidents. Mr. Maestas stated yes.
 - The Fire Chiefs Association is trying to get fire marshal's office out of the PRC office and back into the insurance group. It would cut down costs for administrative purposes and HR. They believe this would be best to get them out of the PRC office.

IX. DISCUSSION ITEMS

A) Llano Ditch

Mr. Maestas stated that he was given direction to go the OSE in Santa Fe to try and find out what surface water rights the Village owns regarding the obligation to the Llano Ditch Association. He researched 4 (four) surface water rights that belonged to the village.

Councilman Gonzales asked Mr. Maestas that if in preparing his report did he seek legal counsel. Mr. Maestas stated no, he worked with the experts at the OSE. Councilman Gonzales stated that we need to seek legal advice before making any decision. This issue has been going on for years and its time we resolve it. He would have liked to see this information put up on the projector for everyone to see.

Councilwoman Gallegos inquired how the OSE could have them registered as ground water since 1974 and this report states that they are surface water. There is a miscommunication somewhere.

Mayor Gallegos stated that the issue was that we had a debt owed to Llano; we were trying to find out where those water rights were; assuming they were ground water. Ms. Jeannie Masters stated that the last time they were paid was when Mr. Jaramillo was the administrator and Malaquias Rael was the mayor. Ms. Masters stated that according to the state statute Acequia Regulation of Water Transfers, 'this recognizes the authority of an acequia to adopt a bylaw, require that an application to transfer water rights out of an acequia be subject to an approval process by the commission of the acequia; in order to exercise its authority, the acequia is required to adopt the bylaw.' Ms. Masters stated that they have done all of this. She stated that going back to the Ortega transfer, this is how we were able to fight that. She stated that they protested when the Cerro de Oro waters were going to be transferred south. She stated that the OSE is supposed to be

working on their behalf but they hired an attorney from Wyoming to represent them on this issue. The State went against us and stated that it would not be detrimental for the water to be taken from us. In turn, our attorney negotiated a \$25,000.00 future loss of assessments for us. She stated she has been the secretary treasurer for Llano since before the federal adjudication was signed in 2000 and the Village has never asked Llano for permission to transfer any water rights from surface to underground. This is why we keep billing for surface. As far as we are concerned they are surface because no one has ever gone through them for permission to transfer them. Councilwoman asked about the OSE records that show them as groundwater. Ms. Masters stated that her records do not show that.

Councilman Ortega stated that maybe we could do a public records request and see their bylaws and the records of where these water rights are located; there seems to be some confusion. We transferred to ground in 1974, maybe there is additional set of water rights that we are not aware of. He believes this needs to be our first step.

 Mr. Danny Garcia stated that in 1974, the state engineers decided to do an adjudication of the water rights. It was finalized in December of 2000. During that time the Marcelino Martinez estate did donate water rights to the Village of Questa for groundwater; it is on the adjudication. These other separate water rights-each one has a separate sub file number. Changes of ownerships have never been done on by the village on some of their properties for the water rights.

Mayor Gallegos stated that we have tried to acquire water rights over the past 5 years in which we have asked the owners of the water to reach out to the associations to get approval before being transferred over to the village. He stated this is a learning experience for all of us. Councilwoman Gallegos stated that she did not know there were not change of ownerships done. She was under the presumption that we always owned them; she asked if this is why we are delinquent at the state, because they aren't under the Village's name. There are a lot of questions and we need to get the attorney's on this.

Ms. Masters stated that as far as the association is concerned, they have not been transferred. She stated that because this has gone on for so long they may have to have their attorney negotiate for future loss of revenues once the water gets transferred to underground as they did with the Ortega transfer.

Mayor Gallegos stated that it is obvious that we have more work to do on this and that we need to get legal counsel involved. Councilman Gonzales state that he would like for legal counsel to review if there is possibly an abundance of water that we have, that is not recorded at the OSE. Mayor Gallegos stated that we may have to ask for funding for contractual help to get this resolved.

B) 2019-2020 NMDOT Local Government Road Program Re: Project Proposal

Mr. Maestas stated that he has provided a list of roads that are in need of repair.

Councilwoman Gallegos stated that she agrees with the roads that are listed. Councilman Jaramillo asked if more funding is needed on Cabresto Road for that project. Mr. Maestas stated that he is not sure how far the MAP and COOP projects are going to get us.

Councilman Ortega stated that we should discuss the Cabresto Road project; we still had a ways to go. Also, he would like to see Embargo Road added to the list. Councilwoman Gallegos stated that she understood that we already identified enough money for Cabresto Road. Councilman Jaramillo stated that he thought that WH Pacific said that the CDBG would cover Cabresto Road. Mayor Gallegos stated that they needed \$1.2 million to go from Gary Sanchez's to the visitor's center. He stated that Embargo Road needs work as well as Cottonwood.

It was decided to get some quantities together for various local roads. With the addition of Embargo Road to the list.

Mr. Maestas stated that he will call the state and ask if we can use it to finish Cabresto and if there is funding left over we can use it on Embargo.

Mayor Gallegos suggested Mr. Maestas ask the state if we can split the MAP project up, if Embargo Road qualifies as a MAP project and if there is money available for bridge repair. Also how much lineal feet we need to cover. Bring this information back to the Council on the meeting of the 12th and we will decide then.

Councilman Jaramillo stated that the Village has been criticized in the past for not attending meetings; at the same time, if Mr. Maestas attends a meeting we criticize him for being out of the office. We need to support the staff if we have them attending these meetings.

- Attorney Fees We have only been billed through October.
- Police Officers Overtime is already at 75%

Councilman Gonzales asked if someone has gone out to the contractors to see if they have a CRS number. She stated no, we have not sent anyone out. Mr. Maestas stated that every business registered with the Village receives a personal letter from him with the location number for the Village.
