The Village has the option to renew the contract every year for up to 4 years or go out for quotes. Councilman Gonzales asked what the cost will be. Ms. Coleman stated that the cost is \$23,040,94.

Ms. Shannon stated that she took the ending balances from FYE 2019 and entered them into the budget that was previously approved back in May.

The following necessary adjustments were made:

- 1. A transfer to cover the GO Bond expenditures in Fund 218
- 2. Voided 2 checks in which money was not received until Monday.
- 3. Rental Enterprise for the Business Park were increased so we would not be over budget.

Ms. Shannon suggested that we really try and build our cash balance.

Mayor 117 118 Gallegos stated that Councilman Ortega has been adamant about not voting yes to pass the budget until we 119 have an Administrator in place. Mayor stated that we can further the conversation and see where it goes in order to get it resolved or if we are not able to resolve this we will not be able to turn in the budget in on 120 121 time. Mayor Gallegos asked Councilman Ortega if he had any comments. 122 123 Councilman Ortega stated that it is not about Ms. Martinez being the Administrator, he has 100% confidence in her ability. He stated that he cannot pass a budget where money is approved for one thing and being spent 124 elsewhere; he does not even know where or how it's being paid. 125 126 127 A discussion was held regarding the Administrator pay and how it was distributed. 128 Councilwoman Gallegos stated that she believes that bringing in a new Administrator at this point, with all 129 the projects that are going on, would not be a good idea. Councilman Gonzales stated that he has a problem 130 with us not approving the budget. Mayor Gallegos asked Councilman Ortega if he would consider changing 131 his NO vote to a YES vote; or if not, so we can adjourn. Councilman Ortega asked if we could have an 132 Executive Session in regards to Personnel Matters. 133 134 135 A motion to amend his original motion of the approval of the agenda to add Executive Session was made by Councilman Gonzales.
