A) Update on US Capitol Christmas Tree-Mr. Ricardo Martinez, District Ranger, Carson National Forest

Mr. Ricardo Martinez updated on the following:

- 1. A magnificent 60ft Colorado blue spruce has been selected in the vicinity of Red River in the Carson National Forest. Cutting ceremony will be November 6th; it will take about 4 or 5 days to package it.
- 2. The cross country tour will begin in Questa on Veteran's Day. It will continue to Red River, over Bobcat Pass to Eagle Nest for a visit with the schools. It will continue up to the Vietnam Memorial in Angel Fire for a photo op and concluding the day in Taos. The goal is to get through all the districts within the Carson National Forest as well as each National Forest. There will be an event in Santa Fe with the Governor. Last stop in NM will be in Alamogordo and then on to El Paso, San Antonio and into Louisiana; over to Atlanta and on to Washington, DC. There will be 29 stops across the country in the course of 14 days. It will be delivered to the US Capitol on November 25th.
- 3. One of the themes of this celebration is Smokey's 75th birthday.
- 4. 70 companion trees will be going along with the tree.
- 5. They will support the Village of Questa in any way with the kickoff celebration which will be held about 10:00am on November 11th. Because it is a holiday, we want to make sure the Veterans are also celebrated front and center.
- 6. The rig that will be transporting is about 100 feet long total with an 80 foot trailer. Kenworth is one of the sponsors and they always donate an off the line semi for this event.

Councilwoman Gallegos asked when the ceremony will be held in Washington. Mr. Martinez stated that the tree lighting ceremony will be held on Wednesday, December 4th.

Mr. Martinez also stated that they were beyond their goal with the ornaments; last count was at 10,300 ornaments. He also stated that he would be back as the event draws closer to give the Council another update.

Mr. Barry Roth updated the Council on the Business Park Project. He presented the finalized plans and specs. The plans need to be reviewed by the NMED as well as CDBG. The plans will be electronically available on their website. He stated that if the Village has any contractors that are interested in the project they can access them on their website. They are waiting on the approval from the funding agencies to move forward. Councilman Gonzales thanked Mr. Gabe Cisneros and Mayor Gallegos for all of their work on this project.

Ms. Karen Menne-Jacobsen updated the Council on the Cabresto Waterline Project. She stated that they should have a design within a couple of months for review. There were a couple of obstacles. It is not a super complex project but the road is very narrow. Mayor Gallegos stated that he feels comfortable breaking ground in April. Staff is making sure we are hitting all the benchmarks so we are able to apply for CDBG again next year.

VIII. DISCUSSION ITEMS

 A) Review of Ordinance No. 2015-141 Water/Sewer Ordinance – Ms. Nadine Herrera, Utilities Clerk

Ms. Herrera went over the following items that she feels need to be addressed:

• Page 5, Section 6B-4 – Requested that the lot, block or tract numbers be removed and we request a copy of the deed. Attorney Chris DeFillippo stated that would should keep it as it reads and add 'by providing a copy of the deed.'

 • Page 12, Section 8D - Disconnect and Reconnect Fees – Requested that fees should be higher for weekend, after hours and holidays. A discussion was held regarding the fees cover the costs of the overtime for public works employees. Attorney Chris DeFillippo suggested the customer give a notice when they want their water on. A discussion was held regarding possible fee amounts.

- Page 16, Section 103-III- Bulk Water rates need to be updated and reflect the tax of 5%.
- A discussion was held regarding a new connection fee or application fee for new customers.
- Rental/landlord agreements are not clear. Who is responsible party? Who is the customer?
- Page 16 Monthly sewer charges were discussed and Ms. Herrera thought the sewer charges should be more comparable to water. A discussion was held.
- Vacant properties and sewer costs. Is there an option to cap their sewer so they don't have to pay the monthly fee in regards to the sewer bonds? It was discussed that the bond fee was rated by the amount of the connections. Each property needs to pay their share. After the bonds are payed off in two years, we can make the decision of possibly no fee to vacant properties or unoccupied homes.
- Page 18 Section 12A Property owner and customer needs to be clear. Mr. DeFillippo recommended taking out this language and making the property owner responsible.

Mayor Gallegos thanked Ms. Herrera.
