VII. <u>RECOGNITIONS</u> – Ms. Sharon Nicholson, Questa Public Library Director - 2019 Taos News Unsung Hero Recipient.

Ms. Nicholson was recognized by the Governing Body for her 2019 Unsung Hero award. Ms. Nicholson was presented with a Certificate of Appreciation.

A proclamation was also presented to the Friends of the Library by the Governing Body or their support of the library.

VIII. PRESENTATIONS

A) Questa Economic Development Fund Board Update – Ms. Lindsay Mapes

Chairman Malaquias Rael updated the Governing Body on the following:

- Cambalache was a success this year.
- Questa Creative Council worked on getting the permanent history trail signs up.
- Working on getting easements for the welcome signs.
- Lodging Pilot Project received \$100,000.00 grant from Chevron to move forward with the project.
- Pick Your Poison race was held with 70 participants and was very well attended and continues to grow.
- Farmer's Market ended their season in September.
- The QEDF has brought in Mr. Michael Gaillour as their new trustee.
- The QEDF is working on their budget for the next year and hoping for another successful year.

Councilman Ortega asked if there was any data collected during the Pick Your Poison Race regarding the number of people coming into Questa and contributing to the businesses in the community. Chairman Rael stated that he will see if he is able to get some numbers.

B) Veteran's Memorial Dedication Request - Mr. Larry Sanchez

Former Councilman Larry Sanchez requested from the Governing Body that the Veteran's Memorial in town be named after the late Senator Carlos Cisneros. He was instrumental in securing the money for purchasing the property that the memorial is located on today. He progressed the memorial to include the Vietnam wall for the Veterans who were not honored when they came home. The late Senator also helped with the purchase of the Town Clock at the memorial.

Mayor Gallegos stated that this item will be placed on the agenda for the next council meeting for action.

C) North Central Regional Transit District -Transit Service Plan Update - Mr. Chris Cordova

Mr. Chris Cordova and Ms. Delilah Garcia were present to get input from the public regarding possible improvements to the blue bus program as well as identify the things that are working. Some suggested items form the public were:

1) Northern stops need some shelters from the inclement weather.

2) Weekend service needed

- 3) Parking locations/improvements for bus riders
- 4) Modifications to place stops further off the roadway
- 5) Concern about intoxicated riders on the bus
- 6) Safety concerns at stops and on the bus
- 7) Transportation for Veterans to get to the Veteran's hospital

The Governing Body thanked Mr. Cordova and Ms. Garcia for their presentation.

D) Possible Presentation by Dollar General Store Developers

Copies of the plans were presented to the Governing Body by Mr. Drew Crosby regarding the proposed

building. Property was purchased in town. They also stated that they have been speaking with the Mayor regarding the location possibly being located north of Questa at the business park. Some of the concerns from the Governing Body and the public were:

- Councilman Ortega inquired about the building material that will be used. The developers stated that masonry would be used in front, a metal roof and metal sides. Commercial glass on the front and entrance doors. Councilor Ortega asked how many employees will be hired locally. They did not have a definite answer.
- Councilman Jaramillo inquired about why the developers chose Questa with Family Dollar already here; is there enough business in Questa. How were the analytics done? They stated that the Questa location meets their requirement in being successful. Also, how will the lighting affect the homeowner that lives next to the proposed store? They stated that there will be a photometric plan designed. Councilman Jaramillo asked if they have met with the NMDOT. They stated they have not met with them; it comes later on in the process.
- Councilman Gonzales asked what they are looking for from the Village. They stated that the Village will look into the plans being in compliance with Village ordinances that are currently in place. If there is any approval done by the County, it should come before the Village first. He stated that he is not in favor of this store being brought to Questa.
- Councilwoman Gallegos asked when construction would begin. They were not sure; there are more steps that need to be completed. Inquired about if there are plans to hire locals and also regarding the building materials, would they utilize local businesses to purchase the materials. They stated that they will hire locals as much as they possibly can.
- Ms. Betty Richter asked to see the plans because this is going to impact her life. She is concerned about the traffic. She inquired about why she was never contacted about this; she feels like it was being hidden from her. They stated that they do not normally talk with adjoining land owners.
- Mr. Malaquias Rael asked what he hours of operation are. They stated they are usually 8am to 8pm. What is Dollar Generals estimated operating sales. They did not know that information. His biggest concern is the traffic study because of the entrance and traffic.
- Ms. Holly Howard asked if there is a regional manager in this area that oversees Northern New Mexico.
 They did not know that information since they are developers. She stated that she does not agree with
 this store coming to Questa.
- Mr. Juan Cisneros asked if the Dollar General representatives will come at some point to answer questions. Mr. Crosby stated that he does not believe that they typically answer questions from municipalities. Mr. Cisneros asked if we asked them to come would they? Mr. Crosby stated that he cannot speak for them but they can convey the message to the division they work for.

Mayor Gallegos thanked the developers for their presentation.

Councilman Gonzales informed the Governing Body that he met with people from Economic Development in Santa Fe and Representative Jim Trujillo. They would like to be on site after November 15th to look at the La Cienega School to see if they will be able to help us with additional funding. Councilman Gonzales stated that we have asked for water testing for all households and Chevron has not come through. Also, we need to begin looking for the next step regarding the 2 foot cover; we need to decide if we are going to allow the 2 foot cover for the dam. They are not sticking to the ROD. He does not want to be blindsided by Chevron. We need an update from Dr. Miller. Mayor Gallegos will see what answers he can get.

Councilwoman Gallegos stated that she was disappointed that we did not have our last meeting; she would rather come to two meetings for 1 hour each than to have to sit at one meeting for 3 hours.
