# IX. MATTERS FROM MAYOR AND COUNCIL

Councilor Ortega requested that the Water Rights item from Ms. Karen Cortez be placed on the agenda for the council to make a decision on. Also, regarding the hold up on the Fiscal Agent issue. Councilor Ortega stated that he spoke with Steve Lacey at DFA and they now want to use the initial agreements prepared by the Village. Their attorney's do not want to do it anymore. Councilor Ortega stated that we need to hold a Work Study Session to discuss the ongoing projects so we can move forward on them. We also need to get Gabe Cisneros on the CDBG project. It was decided to hold a Work Study session. Mayor Gallegos asked the Council to assist Ms. Trujillo with these projects with their expertise and knowledge. Councilor Jaramillo suggested that Mayor Gallegos assist Ms. Trujillo with prioritizing. Councilor Ortega agreed for the reason that we need these projects to get done. He is willing to assist her but she needs to take the lead. Councilor Ortega suggested a Work Study session outside of a meeting even if it is on a weekend. He stated that something need to happen regarding these state agencies holding us back.
