VIII. PUBLIC HEARINGS —

A) Village of Questa Water/ Sewer Ordinance No. 2015-141

Mayor Gallegos opened the public hearing at 6:08pm.

Ms. Trujillo stated that on page 15, the sewer connection fees have been increased by \$300.00, which was requested at the last meeting. Also, on page 16, Item 3, bulk water fee, Ms. Trujillo proposed a fee structure. Currently, it is \$30.00 per 1,000 gallons. This will help with customers who would like to purchase less than that minimum.

 Councilor Ortega, Page 20, Item J inquired if this is the item that the administrator has the authority to waive penalties and interest. Mayor Gallegos stated that no penalties and interest will be waived. A payment plan will be in place instead on the past due amount and the customer will continue paying the current. If the customer does not comply with the payment agreement, the water will be turned off and the agreement will be void. No penalties will be waived. Ms. Trujillo stated we are giving the customer the opportunity to catch up with their bill.

Councilor Cisneros suggested a work study session be scheduled regarding this ordinance. Mayor Gallegos stated that the staff has worked very hard to get this ordinance where it needs to be and we keep putting it off. He stated that if a work study is scheduled that everyone needs to participate; not only to the work study but attend the meetings, otherwise it prolongs the staff to move forward and ends up affecting our audit. Councilor Cisneros stated that there shouldn't be a time limit for working on ordinances when it is going to affect each individual. We need to make sure it is done right.

Mayor Gallegos then asked the Council if we should give Ms. Trujillo direction to follow the current ordinance which is in effect which states that after 45 days of being delinquent the water must be shut off. We are currently in violation of our own ordinance and we are looking at another audit finding. Councilor Ortega stated that he agrees with the Mayor in regards to there being 100% attendance if another work study session is scheduled. Councilor Ortega inquired if we can have the work study session soon so that it can fall into the 45 day window and hopefully this ordinance can get in place before that deadline comes up. Mayor Gallegos stated there are deadlines that need to be met regarding advertising.

Councilor Jaramillo agrees with having the work study session and stated we should have it sooner than later.

Mr. Jim Vaughn stated that we have been putting it off for six months already. If the Council puts it off again aren't there already people who are past the 45 days that their services would have to be shut off? Mr. Vaughn stated that the ordinance has already been hammered out and published. Ms. Peggy Cross stated that the Council is a decision making committee and needs to make up their minds. It needs to be done.

147 A discussion was held regarding the date of the work study session.

Mayor Gallegos asked if there were any more comments from the public. There were none.

Mayor Gallegos closed the public hearing at 6:26pm.

B) Village of Questa Animal Welfare Ordinance No. 2015-142

Mayor Gallegos opened the public hearing regarding the Questa Animal Welfare ordinance at 6:26pm.

Ms. Trujillo stated that the last of the changes were made last month. The name change from Questa Animal Control ordinance to Questa Animal Welfare ordinance was made.

Mayor Gallegos asked for comments and suggestions from the public.

Mr. Jim Vaugh asked about what will happen now, do we have to start from square one? We understood that the ordinance was ready and would be approved tonight. We attend meeting after meeting to review it, with those who attend, and we are ready to move forward.

Ms. Peggy Cross addressed her concerns about abuse and cruelty to animals.

Mayor Gallegos asked the Council to express their concerns with the ordinance. Councilor Cisneros stated that he is concerned about animal abuse and if there is any way to enact something immediately that would address this issue.

Mr. Joe Cisneros asked the Council if they were not tired of seeing them come to the meeting begging and pleading to get this ordinance in place. Ms. Peggy Cross stated that this is disgusting already, this is an animal control ordinance that every town in the country has. Mayor Gallegos stated that we are concerned with the enforcement portion of this ordinance. Ms. Cross stated that if the ordinance was adopted we could call law enforcement. Councilor Romero stated that if the county is called in they will site on the county ordinance. The county and the Village are two different jurisdictions.

Ms. Janice Vaughn stated that a work study session was scheduled sometime back and Councilor Cisneros didn't show up.

Councilor Cisneros stated that some of his concerns with the ordinance are:

- Defecation and Urination He doesn't think this is necessary, this is not the city. Mr. Jim Vaughn stated to Councilor Cisneros that we had scheduled a work study with you that you did not show up to and no one had the courtesy to call us and cancel. We sat here for 25 minutes waiting for you. Mr. Vaughn told Councilor Cisneros that he has had every opportunity in the world to voice his opinion on this ordinance. It has been beat to death and everyone has agreed on it and that is why it has been advertised for approval. Mr. Vaughn stated that he does not understand why Councilor Cisneros is coming in now and wanting to change everything. Councilor Cisneros stated we haven't passed it so technically I have this right. Mr. Vaughn stated that Councilor Cisneros also has the right to at least to have the respect to show up to meetings.
- Animal Noise A discussion was held regarding if this item is enforceable.
- Dogs Running Loose He has a dog that lives outside and can do anything she wants. What should we
 do, lock her up? A lot of dogs are running loose.

It is 1,700 ft. at \$15.00 per foot. Along with that, they will give us allowances for the empty lots with a final cost of \$23,500.00. Another option is the Village can go door to door along that area to see if any other households will commit to hooking up to the gas service which we will get credit for. Councilor Romero asked if the fund board would help fund this. Mayor Gallegos stated that he has discussed this with Mr. Rael, Chair of the QEDFB and he was comfortable with the idea that the funding would come through them. Councilor Jaramillo thought that the fund board said they would fund up to \$ 15,000.00 which would leave the cost to the Village of about \$ 8,500.00.

Councilor Cisneros asked Attorney Vanessa Chavez what the Village's liability would be if we acquired the property. Ms. Chavez stated that the Village would not be liable for anything that has happened in the past, the liability would take effect on the day of acquisition. Anything that the Village opens it up to would have to meet air standards, the asbestos issue is taken care such as if it has to be removed. Once the Village takes it on, the Village will have to make sure that no one has free access to that building until all needed remediation is done. Councilor Cisneros stated that he would hate to pass up on this opportunity. Councilor Romero stated that we should take the property but is concerned if we have the money for remediation. Councilor Ortega stated that his concerns remain and believes that it is going to cost a lot of money to get it to where it needs to be for occupancy as well as demolition costs. Councilor Ortega stated that in reading the audit that the school provided, this facility has a negative value to it. He stated that these concerns still remain. Councilor Jaramillo stated that it is nice to get something for the community. It is possible for the property to be revitalized through Mr. Charlie Deans revitalization plan. This property could be used for the senior center. He stated that he is not opposed but does not want to acquire it if it is just going to sit there and we get the bad name for not following through. Mayor Gallegos stated that these are all valid concerns. Mayor Gallegos stated that he has done some homework and in talking with Mr. Charlie Deans, there is money available to get this property cleaned up. Mayor Gallegos has also met with Mr. Mike Trujillo of the Taos County Senior Center regarding going for ICIP monies to assist in the renovation. Mayor Gallegos has also spoken with members from Senator Udall's office to see if this property would qualify for historic preservation/renovation grants. Mayor Gallegos stated that there have not been any break-ins into these buildings. Ms. Chavez stated that the Village has to make sure that no one is on that property. Mayor Gallegos stated that he believes that it is more of an opportunity for us than a burden.
