Village of Questa Regular Meeting DECEMBER 27, 2016

APPROVAL OF MINUTES

To approve the agenda as amended. All voted yes. Motion carried.

A. La Cienega Property

Ms. Trujillo informed the Governing Body that the NM Board of Finance approved the transfer of the La Cienega School property to the Village of Questa.

B. Municipal Water Supply Update

Mayor Gallegos gave a brief update.

Mr. M. Jay Mitchell, Cabinet Secretary for the NM Department of Homeland Security and Emergency Management informed the public about the procedure for the declaration of an emergency. He informed them that the Village of Questa is currently under an emergency executive order. Notifications are required within 72 hours; the Village of Questa notified our office within the first 4 hours. It was confirmed by the Taos County Office of Emergency Management who sent someone up immediately. This allowed us to contact different agencies without having to wait for authorizations, to begin mobilizing. This all happened within the first 24 hours. Since then, daily updates have been going to the Governor's Office. His team is working at the Cabinet level with NMED and the Office of the State Engineer to get permitting done immediately. The water tests are needed for health and safety requirements. These tests went through fairly rapidly. Fire Department tenders from Taos County and Colfax County were put on emergency response orders in case of a fire. His department has been monitoring the cost of the emergency with daily updates sent by the Village. They are determining the allowable and non-allowable costs. The Executive Order was in place on the Tuesday that the emergency started. Secretary Mitchell stood for questions.

- Former Mayor Bobby Ortega thanked Secretary Mitchell for being here. He stated that this is week 3 with no water. Mr. Ortega stated that we need help now. We need experts and we need resources. He inquired about the resources that his office has to offer in order to resolve this issue. Secretary Mitchell stated that this is an internal failure inside the system and problems with the historical aspects of the system and understanding how it operates. Secretary Mitchell state that they are looking into several contractors across the state. Mr. Justin King of King Enterprises, who has assisted with water issues throughout the state is already in conversations with the Mayor. If they can't isolate the problem with your public works foreman who has history of the system by tomorrow, the next step is to get outside help from a contractor. The state does not run a public works department, none of our agencies have these services or expertise readily available; if we had them they would be here. They rely exclusively on contractors. Mr. Ortega stated that we need help; bring the resources that are necessary. Questa is a small community with a limited budget. Mr. Ortega hopes that this message is communicated to the governor.
- Mr. Ben Herrera stated that he used to be the public works superintendent here and ran this system for a long time. The bottom line here is that we need another well; three wells.
- Ms. Phyllis Zimmerman stated that if the water is shut off to everyone, even the ones who currently have water, we are going to have a bigger mess with frozen meters and busted waterlines. Ms. Zimmerman stated that this is the 3rd meeting she has attending regarding this issue and nothing is being resolved, we are chasing our tails. We all want to know what is going to be done. When is this problem going to be fixed?
- Ms. Louise Gallegos stated that she asked specifically asked Mayor Gallegos at the last meeting if the Governor's Office has been contacted and the answer was no. Now we are being told that they were contacted 4 hours into the emergency. Ms. Gallegos stated that we should have been told last week that the Village was going through the process of what was needed to do; instead you said no. She stated that the Mayor is losing credibility and she does not want to see that. We need to solve this problem, regardless of whenever it started.
- Former Mayor Malaquias Rael stated that we need boots on the ground to look for leaks.
- Former Mayor Charlie Gonzales stated that Mr. Leroy Romero has a well that he wants to sell. It just needs to be tested and in this type of situation the Governing Body needs to look at what it takes to activate this well.
- Former Mayor Esther Garcia asked why we didn't dig the new well deeper. Whose suggestion was it to dig 500 feet? Are you sure the aquifer is not going down. She wished the well driller would have been here tonight so that we could have asked him some questions. Ms. Garcia asked why we would drill a new well right next to the one that dried up. She wants answers.

- Mr. Leslie Trujillo stated that he attended a meeting at the firehouse sometime in 2011 where Mr. Danny Garcia expressed his concern about where our water is going. It has been an ongoing problem.
- Ms. Kelsey Zimmerman asked Secretary Mitchell if the state engineer's office has found any issues. Is the pump big enough, is there enough water in the aquifer and/or is it a leak? Do we have an engineer on hand right now? Councilor Lawrence Ortega stated that this Governing Body will be making this decision today or tomorrow.

Councilor John Anthony Ortega stated that he is hearing two different stories. One is 15% of the community is out of water and Secretary Mitchell stated that it is 20%. He asked for clarity on this. Mayor Gallegos stated that by the phone calls we are getting into the office and the ones we are making we are gaging this. The staff is doing all they can to get this information. Mayor stated that there needs to be some collaborative effort between this Governing Body and the staff to help us out. He stated that there have not been councilmembers here helping out. Councilor John Anthony Ortega stated that he does not agree, he has been here; he has been out of work for 3 weeks and has exhausted pretty much all of his vacation. Councilor Lawrence Ortega stated that this Council has not had a meeting in order to make decisions. Mayor Gallegos stated he is self-employed, that is neither here nor there. He apologized and stated

- Ms. Krystle Cisneros stated that our lives still go on without water. Our kids have not gone to school and that
 is upsetting. She stated that the Mayor and the Council are accountable for this. Somebody needs to be held
 accountable for this.
- Ms. Andie Ortega stated that she has never received a phone call. Yesterday was 3 weeks with no water at all. Last week it was said that we may have water for Christmas and we did not. It was very hard.

Mayor Gallegos stated that we do need professionals to come in and help us. Ms. Andie Ortega stated that this should have happened from the beginning. Mayor Gallegos stated that she is right, he is not going to hide behind anything. He stated that we are working it the best we can with the information we have. There is no owner's manual; just raw experience that has been passed on from employee to employee. This is the way it has been for ten or fifteen years, if not longer. This is the fault of a lot of mayor's and council that have sat up here. We are the Governing Body now that has to bear this burden. We are trying to get a grasp on the system so that we can have a steady flow of water running through the system.

- Ms. Judith Cuddihy asked if we have a physical map of the system. Mayor stated that we do. Ms. Cuddihy asked that Mayor Gallegos confirm to the public tonight that he will get an engineer in here tomorrow. Mayor Gallegos stated yes.
- Former Mayor Malaquias Rael addressed Mayor Gallegos about his comments as well as the comments from the public regarding that this is a problem that has been passed on. He stated that the Mayor knows as well as anybody, and also Councilor Lawrence Ortega, former engineer for the Village and also Councilor Jaramillo that the amount of resources that have been put into this water system have been substantial. There has always been improvements to the system. He stated that he thinks that the best thing for this administration to do is not waste your breath and any time on trying to scapegoat the previous administration's efforts or lack of efforts on the lack of improvements or improvements done to the system and focus on the problem at hand continuously. This is all we can do.
- Former Fire Chief Max Ortega stated that the Mayor and Council need to get the staff some help. He hears every day that people don't know what is happening. People need to be informed at least once a day. We need the community to step up and help. The youth are helping every day.
- Mr. Lloyd Varela asked if Chevron Mining has offered to assist with the expenses that have been incurred.
 Mayor Gallegos stated no.

Councilor Brent Jaramillo stated that we have hired Wilson & Co., an engineering firm to write the report for the production of the new well.

that it does not matter who's been here or not.

- Ms. Phyllis Zimmerman stated that his has also been a financial burden on people having to drive to Taos or Red River to shower or to the laundromat. She was also concerned about checking on the elderly and the homebound. Ms. Rosie Cisneros stated that she checks on the people that she delivers meals to.
- Mr. Jake Lafore asked for an update regarding the permanent hook up for the well. Mayor Gallegos stated that he spoke with Mr. Vigil today and he is going to come in and start digging the line and prepare for the tie in. Mr. Lafore asked if a shutdown of the system will happen. Mayor Gallegos stated no, we will leave well #1 running. Mr. Vigil believes he can do this is one day.
- Mr. Dennis Michem asked if showers could be brought in by the National Guard so people don't have to commute. Mr. Michem asked that Council to consider this.

Councilor John Anthony Ortega stated that we had an incident command system set in place and it got pushed aside, he is not sure why it did but with that system in place, we were able to have Mr. Tommy Lyles here to put information out.

- Mr. Danny Garcia stated that after reviewing some of the maps and going to the PRV's and valves, a lot of them are under the dirt or pavement and we don't know exactly where they are at. There was a system improvement in 2005, in Lower Embargo an 8 inch pipe was placed for over 6 miles. That is over 100,000 gallons of water; half of the water is just going to fill that line.
- Mr. Jason Gonzalez stated that he will be here tomorrow to help with boots on the ground and volunteer his time.
- Former Mayor Bobby Ortega stated that it is up to the Governing Body to make the decisions. What should we expect? Councilor Lawrence Ortega stated that he is committed to get the professionals that we need here to assess the situation and find the problem and go from there. We can't spend another week or two looking for a leak. Councilor John Anthony Ortega stated that he agrees with what Councilor Lawrence Ortega said. He stated that the emergency isn't over because the well was drilled. We are still committed to finding leaks and fixing PRV's and valves. He stated that he believes we should stay in emergency mode until everything runs correctly and everyone has good water.
- Former Mayor Lawrence Gallegos stated that the employees and Mayor have been here every day since this has started. He believes they should be thanked instead of criticized. Former Mayor Bobby Ortega stated that he did thank them earlier and he knows they have been working hard. He also stated that this is not a personal issue, it is a community problem that we need to work together on to get solved. Councilor Lawrence Ortega stated that he spent the day with the Mayor and the crew telling them how the system works and what they should do.
- Ms. Gloria Gonzales stated that she believes that pointing of fingers and the blame has to stop here and now. The Village is doing a wonderful job. They check on me and my daughter every day, and so does the Mayor. What has to be done is we have to uplift our Mayor and the staff so they get motivated. We need to embrace the Mayor and the Council. God is the main source. We need to listen and work together.

C. Possible Funding Sources for Water Emergency

Ms. Trujillo stated that she reached out to the Los Alamos Foundation to seek assistance in paying Mr. Amalio Madueno to help apply for grants to assist the Village. They did approve the request. Mr. Madueno has filled out an application to the NM Board of Finance; the Resolution is on this meeting's agenda for approval. He is also in contact with the USDA. The Village Attorneys have also reached out to the NRDA to see if we can get these monies for this emergency.
