VI. <u>PUBLIC COMMENTS</u> - (It is the policy of the Governing Body to accept public comment. Because your particular issue is not on the agenda the Governing Body cannot respond immediately, but may direct staff to address issues at a future Council Meeting. Public comments are limited to a maximum of three minutes.)

Ms. Trujillo introduced Mr. Michael Steininger from the Department of Finance and Administration. She informed the Governing Body that Mr. Steininger will be here this week to assist us with some accounting in the Finance office. Mr. Steininger informed the Governing Body that he and Ms. Shannon are currently attempting to get the cash balances in align with the bank reconciliations. He stated that he has spoken with our auditors on what in the audit report I can rely on and what I should not because of the reason that the last audit was disclaimed. He stated that as the Governing Body gets into the budget cycle, there are a few things that are concerning him: 1) Like many communities, Questa seems to be burning through the cash. 2) 72% of the water receivables are delinquent. He stated that while the State takes no position in how the Village enforces ordinances, he strongly suggests that we adopt the ordinance because collections will be harder to collect if the balances keep climbing. He stated that this is all he has looked into in the past couple days and stood for any questions. Councilor Ortega thanked Mr. Steininger for being here and for his review.

• Chief Gerald Bates stated that he has provided the Council with a report that was not available at the time the packets went out.

Mayor Gallegos closed Public Comments at 6:13pm.

and South side. There is currently fencing on the East and West side. (2014 Grant) Construction and bid on RSA grading and obstruction removal. This project is ready to bid and waiting for the okay from FAA and the Village. (2015 Grant)

Received a small state grant for \$5,000.00 to try and remedy the lighting problems. Because there are only a select few of electricians who can work on airports, we called in Bixby Electric to troubleshoot. Councilor Ortega inquired if the hiring of the contractor was under State contract. Mr. Archibeque stated that they received a quote from Bixby that they found to be reasonable. Councilor Ortega asked Ms. Trujillo if she felt that procurement was followed. Ms. Trujillo stated yes, for the reason that this job could not be done by any electrician. Mr. Archibeque stated that in the future if they are required to solicit more quotes they can certainly do that. Councilor Ortega stated that they should follow our local procurement policy. Councilor Ortega asked if the other projects will be going out for bid. Mr. Archibeque stated that they will. Councilor Ortega would like to see the bids in the Taos News since it is local. Mayor Gallegos inquired about the grading and what would local contractors need to bid. Mr. Archibeque stated that the contractors would have to have a GF-1 or GF-98 license to work on airports.

Last year a design only task order and grant was done for a (Runway Safety Area) RSA grading which

was a 5010 deficiency from the FAA. Also a grant for the design on the wildlife fencing on the North

B) Mr. Mark Breen - Proposed Residential Development Complex

Mr. Breen proposed to the Council to construct a residential development consisting of 12 half-acre (or larger) lots. This would join an existing subdivision on Cerro del Oro Estates. Mr. Breen provided a plat which located that area and lots. He stated that they have reviewed the current zoning ordinance and would also like to hook up to the Village sewer and water. Councilor Ortega asked if they have spoken to the people in that area and will we be holding a public hearing on this development. Mayor Gallegos stated that he wanted Mr. Breen to come in and speak with the Council regarding his plans and from here we would speak as a Governing Body and see how it works into our ordinances to see how we would need to proceed regarding public hearings and so forth. After these reviews the Governing Body would then make a decision as to either approve or disapprove the development. Mayor Gallegos suggested a Governing Body work study session regarding this development. He informed Mr. Breen that the Village would keep him informed. Mr. Breen thanked the Governing Body for their time and consideration.

**At this time Sheriff Jerry Hogrefe gave a brief update regarding the upcoming Memorial weekend holiday activities and operations. He stated that there is a very agitated situation evolving in the biker community in the wake of the recent Waco, Texas situation. He as well as other law enforcement entities have been attending briefings for law enforcement. The State Police will have 15 additional officers running the day shift and 15 running the night shift. The Sheriff's office will handle all calls from the old blinking light south. They will also assist the Questa PD in transporting individuals to Taos if needed. There will be a large presence of law enforcement in the area.

Mayor Gallegos and the Council thanked Sheriff Hogrefe for his update.

VIII. **PUBLIC HEARING** -

Ordinance No. 2015-142 to amend Village of Questa Ordinance No. 2010-136 -Re: Economic Development Project-Taos Mountain Energy

Ms. Vanessa Chavez stated that one of the questions that came up at the last public hearing was if the Village would own the equipment at the end of the lease. She stated that she confirmed that the way it is structured is that all of the items attached to the building stays with the Village; however, the other equipment will be kept and owned by Taos Mountain Energy. She stated that the reason they structured it this way is that Taos Mountain

Energy has to give a security interest in property in order to secure the funding they are receiving and secondly because that property will be used pretty heavily it is going to depreciate. So to require the Village to take that on after it is depreciated would not work for the Village. This is the way the agreement was structured by NM Economic Development.

Mayor Gallegos opened the Public Hearing at 6:47pm and asked if there were any people present who would like to comment or express any concerns. There were none. Mayor Gallegos then closed the Public Hearing at 6:48pm.

XIII. MATTERS FROM ADMINISTRATOR

Ms. Trujillo informed the Governing Body about the following:

- Our DFA Budget analyst Ivy Vigil informed Ms. Trujillo about an error on Budget Adjustment Resolution 2015-22, that was approved last meeting. On page 3 of the Resolution regarding the Library Fund a transfer in was requested to the Library Fund but a transfer out was not requested from the General Fund. It will be deleted from this Resolution and be placed on the next Budget Adjustment request. Ms. Trujillo stated that because a change was made she had to bring it to the Governing Body and make it public knowledge that the Resolution was changed. It is required that the document is reviewed and the Governing Body concurs that this is acceptable. It was concurred by the Governing Body that this change was acceptable and that they are aware of it.
- Ms. Marie Reynolds has offered to sell her property to the Village of Questa and would like us to let her know if we are interested. Councilor Ortega would like to see an appraisal of the property and go from there. Councilor Jaramillo stated that based on the budget this year it doesn't look like it is possible. Other funding sources would have to be looked at.
- Mr. Andamo Sanchez is interested in selling a water well and water rights to the Village of Questa and has also submitted a proposal. Councilor Ortega stated that before we consider this proposal we have to see an appraisal. Mayor Gallegos stated that if we have funding down the road this is something that is available to us. Councilor Ortega asked if we will then be asking Mr. Sanchez for an appraisal. Mayor Gallegos commented that maybe we should get some funding options in line first. Councilor Jaramillo stated that he is interested. Councilor Ortega stated that the Village does need a new water well. Mayor Gallegos stated that Mr. Sanchez would consider carrying a note with the Village. Ms. Trujillo stated that we cannot carry notes with private individuals. Councilor Ortega stated that he still believes that we should get an appraisal either way. Mayor Gallegos asked Ms. Trujillo to contact Mr. Sanchez for an appraisal.
- Ms. Trujillo gave the Council a copy of the loss control and safety audit on the La Cienega property. She stated that a walk-through of the property has been scheduled for June 1st for the Governing Body and the Questa School officials at 6:00pm.
- Ms. Trujillo asked the Governing Body if they would like her to pursue the COPS grant being that we are in need of another officer. She asked the Council keep in mind that the grant only covers the salary portion. The Village would be responsible for purchasing the equipment, vehicle and benefits. Councilor Ortega asked about other options available. Chief Bates stated that there is really no other option. A discussion was held regarding the scheduling. Councilor Jaramillo stated that he believes that we should pursue the COPS grant. Councilor Ortega stated that he was also in favor of pursuing the grant. It was decided to have Ms. Trujillo pursue with the grant process.
- A Special meeting needs to be scheduled for the approval of the Preliminary Budget that is due to DFA by June 1st. It was agreed by all that the meeting be scheduled for Wednesday, May 27th at 6:00pm.

XIV. MATTERS FROM MAYOR AND COUNCIL

Councilor Cisneros inquired about the IPADS that the Council was going to get so that we wouldn't have to use the large amount of paper we have been using. Ms. Trujillo stated that that they have been purchased and we need to schedule a training. It was decided that the training be scheduled at 5:00pm before the Council Meeting on June 2. Councilor Cisneros requested police presence at Council Meetings for the safety of the Council as well as the public.

Councilor Ortega suggested that a performance evaluation be done for Administrator Loretta Trujillo since she has been here for one year; for her benefit as well as the Council's. Ms. Trujillo stated that she is appreciative of the suggestion. It was decided to schedule the evaluation for Tuesday, June 9, at 6:00pm immediately following the Animal Control Ordinance work study session.
