Mayor Gallegos asked Procurement Officer Ms. Coleman to give a brief update on the evaluation report and the process. Ms. Coleman stated that an RFP was put out in January and was due March 5, 2020. The Village received approximately 9 inquiries throughout the process and two submittals. One from WH Pacific and one from HDR Inc. We followed the evaluation process with both firms and had an evaluation committee comprised of Mr. Toner Mitchell from Trout Unlimited, Mr. Eric Frey with NM Department of Game & Fish, Mr. Russell Church from Town of Red River who is the Grant Administrator and is familiar with these type of projects. There was a total of 375 compiled points that could be accumulated for each entity; WH Pacific received 350 points and HDR received 260 points. WH Pacific was recommended by the evaluation committee. They also signed on with Chris Phillips of River Bend Engineering who is very familiar with the Village of Questa & the Red River area in doing these types of restoration projects.

50 51 Councilman Gonzales asked how long before the project starts. Ms. Coleman stated she would do the award letter today and check with Karen if we have to NOO in place. Mr. Toner Mitchell is very concerned with the runoff and it could affect the surveys. The Village Attorney and Ms. Coleman have been working on a contract.
