- 115 Mayor Gallegos provided the Council with information regarding 3(three) interested Cannabis growing 116 businesses and the proposed areas of interest. They are as follows:
 - Greenworld Taos LLC/ La Casa, Adrian Maestas Proposed location is on Llano Road behind Living Word Ministries Church. There are 7 acres available for purchase.
 - LeRoy Romero Proposed location is on the NW corner of Don Martinez and Shirley Road, Mr. Romero owns this Property
 - Roots & Herbs Proposed location is at the business park; he is interested in having a land lease agreement with the Village of Questa and would like several acres.
- There were many conversations had regarding these proposed grow facilities and their potential to do business in the Village limits. As it stands, any proposed properties that are currently not zoned as agricultural and/ or business, will need to submit a variance request to the Village.
